We've exhausted all our resources, Darrel. The other manufacturer I checked with also needs 10 weeks lead time to get the boxes. They're usually at 6 weeks but they're over extended right now. So nobody can make our deadline for the expiration of the grant money.

The only option at this point would be to request secondary capital funding and buy these ourselves. The bid price was \$44,918 for both. We could salvage the bid that way, but I've no idea if there is any funding available.

I think if we do have the chance to bid this out again in the future we should broaden our scope to include some other manufacturers.
