- b. Install new Northern Lights 6kw Generator M673L3-3.
- c. Install new engine mounts.
- d. Wiring harness for generator.
- e. Install new outdrives, supplied by HCSO.
- f. Install new raw water hoses and filters.
- g. Replace gimbal bearings and gimbal bearing carriers.
- h. Replace Main engine Racor filters to include water sensor alarm and light kit for dash.
- i. Replace Generator Racor fuel/water separator assembly.
- j. Replace all bellows.
- k. Modify engine hatch hinges.

2. Page 23 will be replaced in its entirety to include the addition of transmissions to Line A., see attached.
