QUESTIONS AND ANSWERS – AS OF JUNE 15, 2020**

**Question #1:** *Can you please share your current vendor and pricing for line item A? The bid tabulation for the last time linens were out to bid only show a cotton blanket and a wool-blend blanket.*

**Answer #1:** The current vendor and price for line item A, Cotton Blanket, is Tabb Textile at \$63.00/dozen.

**Question #2:** *For line item C, the flat sheet: do you have a specific measurement for the sheet, or is any sheet that fits a 30x76x5 mattress acceptable?*

**Answer #2:** Any flat sheet that appropriately fits a 30” x 76” x 5” mattress is acceptable.

**Question #3:** *Do you have a thread count requirement or preference on line items B, C, and D?*

**Answer #3:** The thread count for items B, C, and D may vary as long as it remains within the required weight of 4.3 ounces per square yard.

**Question #4:** *When the linen portion of this bid was out to bid last fall and subsequently cancelled, we had sent samples at that time. Will we need to send the same samples again for this bid?*

**Answer #4:** Yes. Bid 6-20 will require new samples.

**Question #5:** *On the undergarment samples, would you like each of the 2 samples to be different sizes or the same size? Will you need the screened size indicators on all samples?*

**Answer #5:** Each of the 2 samples shall be of the same size and each sample individually labeled with the Vendor’s name and item number. No, the screened size does not need to be on each sample.

**Question #6:** *Regarding the bid referenced above, can you please advise who was awarded these items before and at what price?*

**Answer #6:** Quotation Tabulation sheets from the last awarded bids are attached. Awarded items are highlighted in yellow on the Quotation Tabulation sheets.

**Question #7:** *Can you please provide the last bid award tabulation and the name of your current supplier?*

**Answer #7:** Quotation Tabulation sheets from the last awarded bids are attached. Awarded items are highlighted in yellow on the Quotation Tabulation sheets. The list of current vendors is below:

**Question #8:** *Can you please provide the exact size of fitted and flat sheet which you are using now?*

**Answer #8:** The current size of the flat sheet in use is 106” long x 66” wide and the current size of the fitted sheet in use is 76” long x 32” wide x 4” pockets.

**Question #9:** *Can we please bid the line items # 2,3,4,5 & 6??*

**Answer #9:** Yes. Line items may be bid in part or in whole as the HCSO reserves the right to award by line item or by overall total, whichever is deemed in the best interest of the HCSO.

**Question #10:** *The “Vendor Application Form,” you’d like to provide the following documentation, “Business Tax Receipt for Hillsborough County or other municipality’s business license.” Would sending our Certificate of Good Standing be accepted?*

**Answer #10:** The Vendor Packet attached as Appendix I must be returned with your Bid Response along with copies of Hillsborough County Business Tax Receipt, other local government, **or** state business license(s). Include any licenses or registrations which may be applicable.

**Question #11:** *Please clarify the specification for Flat Sheets (Item “C”) page 15. The previous bid specification (Item D of ITB 17-19) called for a “finished size to fit mattress size 66” x 96” (+/- ½”)”*

*The spec in this bid calls for “finished size to fit mattress size 30” x 76” x 5”... “  
Is this an error?*

**Answer #11:** The sheets shall fit mattress size 30”x76”x5”.

**Question #12:** *It is stated in the Bid 6-20 that sizes for both fitted and flat sheets are 30" x 76" x 5". Flat sheet sizes are mentioned as, Width x Length with top and bottom hem, for example 34" x 84" +/- 1" hem. The size for flat sheets could not be written as stated in bid, they do not have a drop of 5" like fitted sheets. For example, If you put a flat sheet on a flat surface it will have 2 equal sides with equal length and equal widths, but it cannot have a drop of 5".*

**Answer #12:** The width plus length of the flat sheet should have a finished size to be used on a mattress size 30” x 76” x 5” as stated on Bid 6-20 Part C, Paragraph 2, Item C.

**Question #13:** *What fabric should be used in sheets, woven fabric or knitted fabric?*

**Answer #13:** The fabric used in the sheets may be woven or knitted but must retain the requested specifications of being 50% cotton / 50% polyester (+/- 5%), weight of 4.3 ounces per square yard and shrinkage not to exceed 5%.

**Question #14:** *On the last item....it says CREW sock but then says ankle cuff 2 ½ inches. Do you want a crew sock or an ankle sport sock?*

**Answer #14:** A sock with a 2 ½” ankle cuff is required. The product may be referred to differently depending on the Manufacturer.

**Question #15:** *Item J1 – Crew sock has a description of ANKLE CUFF approximately 2 ½ .....Do you want an ankle sock or a crew sock. Crew socks do not have an ankle cuff.*

**Answer #15:** See Answer #14.

**Question #16:** *Quantity for Line A1 of 50 each seem small compared to other lines. Is this accurate, 50 each or should it be 50 cases?*

**Answer #16:** 50 each is the correct estimated annual usage.
