**MESSAGE:**

This change order is respectfully being submitted to request the addition of the Safariland Basketweave Open Top Flashlight Holder 306-7-4 as an item to this Bid. This item will replace the current Hero's Pride Model flashlight holder as it has been observed to be insecure and received multiple complaints from Patrol Deputies. A sample of the Safariland Open Top Holder was requested by the Supply Distribution Warehouse from Dana Safety for review. It received approval from Command Staff.

To rectify this issue, we kindly request that a new, secure flashlight holder be included in Bid 2023-029 Duty Gear and Related Equipment. The Safariland Basketweave Open Top Flashlight Holder 306-7-4 is designed to securely grip the flashlight and prevent it from falling out during use.

Quotes were requested from all awarded suppliers on Bid 2023-029 Duty Gear and Related Equipment. Dana Safety's quote came in with the lowest cost at \$24.99 for each flashlight holder. I recommend that we amend Bid 2023-029 Duty Gear and Related Equipment to include the Safariland Basketweave Open Top Flashlight Holder 306-7-4. This change will replace item number 24 on the tabulation sheet included for your review.
