### **MESSAGE:**

This change order is respectfully being submitted to request the addition of the Galls brand Sam Browne Style belt as an item to this bid. The original belt awarded, the Acker belt, has been experiencing excessive lead times, which has caused delays in fulfilling our supply needed for Deputies.

Given the critical nature of timely duty gear provisioning for our Supply Distribution Section, it is imperative that we have an alternative that meets our specifications and can be delivered within a reasonable timeframe. The Galls brand Sam Browne Style Belt is a suitable alternative that can fulfill our requirements promptly. Additionally, the Galls belt is available at a lower cost compared to the Acker belt.

After a thorough review, I recommend that we amend bid 2023-029 to include the Galls brand Sam Brown belt. This change will add item numbers 57 through 74 to the tabulation sheet included for your review.

Seller shall not be liable for any delays in filling this order caused by accidents to machinery, differences with employees, strikes, labor shortage, fire, floods, priorities requested or required by an instrumentality of the United States Government or the government of any state, delays in transportation, restrictions imposed by any federal, state or municipal law or regulation, whether valid or invalid, or causes beyond the control of the Seller.

Warranty - Seller shall pass through to Buyer all manufacturer warranties and return policies applicable to Buyer's order. Seller shall take all reasonable actions to ensure that Buyer receives the benefit of such pass through warranties and return policies. Buyer's sole remedies for any goods sold hereunder shall be as provided in such warranties and return policies and shall be solely against the applicable manufacturer. Restocking - If a cancellation of an order or a return by Buyer is accepted or initiated by Seller and/or the manufacturer, it may be subject to a restocking charge at the discretion of Seller.

Delivery and Transportation - Products sold herein are sold FOB at the place indicated on the face of this sales order unless otherwise agreed to in writing by Seller and Buyer.
