SUBJECT: Amendment No. 2 to Bid 7-18 Bulk Fuel Site Preparation & Tank Installation

MESSAGE: Please note and acknowledge the following changes or additions to be included in RFP 7-18:

1. Technical Specifications (Part C)(1)(c) – Replace c. in its entirety as follows:
 - c. Place and finish a rebar-reinforced concrete slab.
 - 1) Required Services: An eight (8) inch thick, above ground, concrete slab measuring 36' x 16' for the fuel tank. The slab shall be positioned north to south on the property.
 - 2) Optional Services: An eight (8) inch thick, ground level, concrete slab consisting of number five (5) rebar on one (1) foot centers, measuring 32' x 14' to provide parking for vehicles while fueling. The slab shall be positioned perpendicular and centered against the fuel tank slab as seen in Exhibit A.
- NOTE:** Optional Services shall be considered as a separate line item on the Proposal Response (Part D), and will be awarded only if budget permits.
2. Technical Specifications (Part C)(1)(f) – Replace f. in its entirety as follows:
 - f. Furnish and install all piping, Gasboy® Atlas®, Model Number 9153KX, single hose, fuel dispenser, containment sumps and all related appurtenances.
3. Technical Specifications (Part C)(1)(g) – Replace g. in its entirety as follows:
 - g. The Gasboy® Atlas® 9153KX dispenser shall include the following options:
 - 1) CX - Pulser (100:1 volume) for key or card system
 - 2) SS - Stainless steel sheathing Kooline (22 gauge)
4. Technical Specifications (Part C)(1)(h) – Replace h. in its entirety as follows:
 - h. Furnish and install an LED lighted aluminum cantilever canopy with steel beams and columns measuring 20' x 20'. The canopy shall cover all equipment including dispenser, card reader, tank monitoring systems and the concrete slab for vehicle parking while fueling. The canopy shall not cover the tank.

5. The Cost sheet on page 29 has been updated – Replaced in its entirety as enclosed.
